The City Council of the City of Ozark, Alabama, met in Regular Session in the Council Chamber of the Municipal Complex at 6:00 P.M. on Tuesday, June 21, 2016. Upon roll call the following members were present:

Councilmember Garrett gave the prayer followed by Mayor Blackwell leading everyone in the Pledge of Allegiance.

The Council having read the minutes from the Regular Council Meeting held on June 7, 2016, President Gilland asked the wishes of the Council. Councilmember Hill made a motion to approve the minutes of the Regular Council Meeting held on June 7, 2016, which motion was seconded by Councilmember Garrett. The Council voted unanimously in favor thereof.

President Gilland advised the Council it was time to set the Agenda and if there were any changes to be made. Councilmember Garrett made a motion to set the Agenda with the exception of items #9, 10 and 11 to be removed, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.

Councilmember Jackson made a motion to approve the City of Ozark Title VI Program Document, which motion was seconded by Councilmember Hill. The Council voted unanimously in favor thereof.

Councilmember Jackson introduced a Resolution Adopting a Title VI Plan and moved for its adoption, which motion was seconded by Councilmember Hill. The Council voted unanimously in favor thereof.

Councilmember Barefield introduced a Resolution Declaring Excessive Weed Growth at 1646 N Union Avenue and moved for its adoption, which motion was seconded by Councilmember Hill. The Council voted unanimously in favor thereof.

Councilmember Garrett introduced a Resolution Setting Compensation for the Absentee Election Managers at \$25.00 per day and moved for its adoption, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.

Chief Marlos Walker recommended that the application for Shaski LLC be read as a first and second reading. Upon the recommendation of Chief Walker Councilmember Jackson made a motion to approve Application 070- Retail Table Wine (Off Premises Only). Applicant: Sakshi LLC., 911 East Roy Parker Road, Ozark, AL. Owner: Arvindkumar N. Patel, 3055 Flynn Road, Dothan, Alabama 36303 as a First and Second Reading, which motion was seconded by Councilmember Barefield. The Council voted unanimously in favor thereof.

Councilmember Garrett made a motion to re-appoint Charles Harper and Steve Schisler to the Ozark Downtown Redevelopment Authority, which motion was seconded by Councilmember Hill. The Council voted unanimously in favor thereof.

President Gilland advised the Council that there was a copy of the Court Report in their packets for review.

With there being no further business to come before this Regular Council Meeting of June 21, 2016, Councilmember Garrett made a motion to adjourn the meeting, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.
